1. Call to Order

3. Consider Approval of Minutes of November 20, 2019

The minutes of the regular meeting of November 20, 2019 were presented for Trustees' review and consideration.

4. Sand Springs Keystone Corridor and Urban Renewal Area Report

City Planner Bates advised Trustees that Sand Springs has been awarded a grant through Oklahoma Municipal League (OML) and the University of Oklahoma. The grant involves the concept of a streetscape project in the downtown area. The project will begin in late March or early April.

5. Downtown "White Box" Program

City Planner Bates went over a proposed "White Box" program which is designed to award funds to downtown business owners and developers who revitalize an existing, vacant, commercially zoned business. City Planner Bates gave examples of what would and would not be eligible expenses. City Planner Bates stated the program will be reviewed and possibly modified before a final product is brought back to the Development Authority for final approval. This item was for informational and discussion purposes only and no action was taken by the Development Authority.

City Planner Bates advised that there will be no executive session.
