3. Addendums to the Agreement with Multi-Clean

City Manager Michael S. Carter requested Council's approval of addendums to the Cleaning Services Agreement with Multi-Clean for monthly janitorial services for the City of Sand Springs Municipal Building (City Hall) and the Spring Lake Municipal Complex – Administration Building, reflecting services for five (5) days per week for each facility, for an additional monthly rate of \$2,500.00.

Following a brief discussion, a motion was made by Councilor Nollan and seconded by Councilor Burdge to approve addendums to the Cleaning Services Agreement with Multi-Clean for monthly janitorial services for the City of Sand Springs Municipal Building (City Hall) and the Spring Lake Municipal Complex – Administration Building, reflecting services for five (5) days per week for each facility, for an additional monthly rate of \$2,500.00.

The motion carried 7-0-0.


4. Communication in a Council-Manager Form of Government
