### Park Reservations

Reservations are accepted by the Parks & Recreation Department Monday – Friday; 8:00am-5:00pm. The Parks office is located in the Case Community Center. Reservations may be made in person or, for an additional \$2.00 convenience fee, over the phone (918-246-2561 ext 1).

All Park reservations are **Non-Refundable**, however, if there is an emergency or weather event, we will help you reschedule.

### Park Shelters

All shelters are \$20.00 per hour with a two-hour minimum, except for the large shelter in Case Community Park. The large shelter rental rate is \$40.00 per hour with a two-hour minimum.

#### **Case Community Park-South (near river)**

2300 S River City Park Rd

- Large covered shelter with 8 tables
- Three covered shelters with 2 tables

#### **Case Community Park North (near splash pad)**

2160 S River City Park Rd

- Three covered shelters with 2 tables (Coming Spring 2019)

#### **Page Park - 1001 N Roosevelt**

- Covered shelter with 1 table; 1 grill

#### **Pratt Civitan Park - 306 W 43rd St**

- Covered shelter with 1 table; 1 grill

#### **Ray Brown Park - 401 E 6<sup>th</sup> St**

- Covered shelter with 2 tables; 2 grills

#### **Sand Springs Lake Park - 1401 E Park Rd**

- Covered shelter with 1 table; 1 grill

### Other Park Areas

#### **Charles Page Triangle – 4 East Broadway St**

- \$35.00 fee per day
- Located in Downtown Sand Springs
- If event is large or requires street closure, contact Planning Division at 918-246-2573 to complete a Special Event Permit.

#### **Stage & Great Lawn –2300 S River City Park Rd**

- \$20.00 per hour with a five-hour minimum rental.
- Located in the south portion of the Case Community Park near the river.
- Multiple 110/20amp plugs around great lawn and stage. Additional electrical power huts located behind stage with plenty of amps for a spider box.

#### **Inez Kirk City Garden – 101 East Broadway**

- \$20.00 per hour with a two-hour minimum
- Small gazebo

### **Volleyball Courts**

#### **Thunder Basketball Court**

- No charge but **for large groups, please call the Parks office to reserve.**
- Both located in the south portion of Case Community Park near the river (2300 S River City Park Rd)
